## Sustainability

O.H. Industri carry out waste segregation for all waste produced in our factories. All offcuts and other forms of timber and wood waste from production is automatically fed back to our heating plant to heat the factories. All other waste is being reduced considerably during continuous waste reduction projects.

O.H. Industri products are manufactured from timber sourced from sustainable well-managed forests. O.H. Industri are certified according to the FSC®'s global labelling scheme for sustainable wood and paper. We use certified wood from sustainable forestry.

Our material suppliers provides environmental information and declarations, establishing a number of standards to ensure that due diligence has been given to both the environment, the type of labour used, and compliance to EUTR (European Timber Regulation) and REACH (Registration, Evaluation, Authorization and Restriction of Chemicals).

### What is:

#### EUTR:

European Timber regulation is prohibiting the place of illegally harvested timber into the European market.

#### FSC 100%:

Means that the wood in the product is completely FSC certified from well managed forests

#### FSC mix 70%:

Means that the wood in the product is from FSC certified forests, recycled material or controlled wood

#### FSC CW:

The FSC controlled wood standard minimizes the risk of using wood products from unacceptable sources

#### PEFC:

Chain of custody certification. Forrest management for tracking certified materials from the forest to the final product.

#### OLB:

Chain of custody certification. Forrest management for tracking certified materials from the forest to the final product.
